Assignor agrees that Assignee may apply for and receive any of the United States or foreign Letters Patent, utility model, and other similar rights anywhere in the world in its own name, and Assignor further authorizes and requests the US Commissioner of Patents and Trademarks or any other proper officer or agency of any country to record this assignment and issue all resulting Letters Patent, Utility Model Registration, Inventor's Certificate, copyrights, and other similar rights to Assignee; and

Assignor hereby covenants and agrees to communicate to Assignee or its representatives any facts known to Assignor respecting the invention, to execute all divisional, continuation, renewal, reissue and foreign applications, sign all lawful documents and make all rightful oaths and declarations relating to said invention, sign all lawful documents which Assignee shall consider desirable for aiding in securing and maintaining proper protection for said invention and to testify in any judicial or administrative proceeding and generally do everything possible to aid Assignee or its successors in interest to obtain and enforce said patents, utility models, industrial designs, petty patents, design registrations, copyrights, and legal equivalents thereof worldwide when requested so to do by Assignee or its successors in interest without further or other compensation than that above set forth; and
