ASSIGNMENT

WHEREAS, Bruce Thrush, an individual residing in San Juan Capistrano, California, (referred to hereinafter as "ASSIGNOR") has obtained, by way of Assignment, 10% of title, right and interest in and to the invention entitled "Resilient Mat", for which a design application for Letters of Patent of the United States of America was filed on January 17, 2006 and assigned serial number 29/252076 and issued on January 5, 2007 under Design No. D543764; which together with related experimental data, trade secret, and other know-how is referred to hereinafter as the DESIGN;

WHEREAS, Parallax Group International, LLC, a company having its principal place of business at 27542 Calle De La Rosa, San Juan Capistrano, CA 92675, USA (referred to hereinafter as "ASSIGNEE"), is desirous of acquiring this 10% of the right, title and interest in, to and under said DESIGN, and in, to and under Letters Patent or similar legal protection to be, or having been, obtained therefor in the United States of America, its territorial possessions and in any and all countries foreign thereto;

NOW, THEREFORE, effective December 8, 2016, for the sum of \$1.00 plus other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over unto the ASSIGNEE, his successors and assigns, 10% of the title, right and interest in and to the DESIGN.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment;

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said DESIGN, including the patent application listed above, and any Letters Patent and legal equivalents in foreign countries issuing therefrom as may be known and accessible to ASSIGNOR, and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said invention and said Letters Patent and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.

Expected Performance. Each party herein agrees to perform all acts and execute and deliver all documents as may be necessary or appropriate to carry out the intent and purposes of This Agreement.


