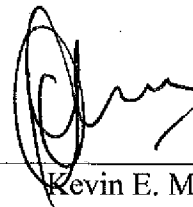

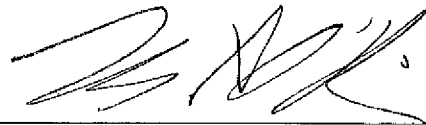
3. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the board of directors.
