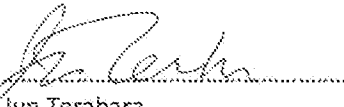
I am a legal representative of SEGA Games Co., Ltd. and am authorized to execute documents relating to industrial property matters including this affidavit on behalf of the company.

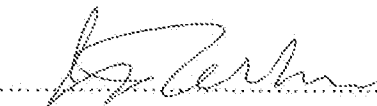
