successors, legal representatives, and assigns, as the assignee of the entire right, title, and interest therein.

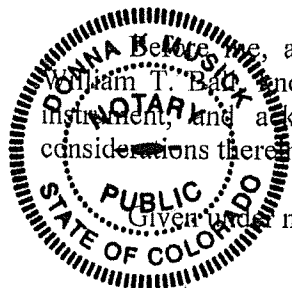
