PATENT ASSIGNMENT

This AGREEMENT, having an effective date of December 5, 2016, is between the following parties:

2. ASSIGNOR represents and warrants to ASSIGNEE that ASSIGNOR is the true and lawful sole owner of a one-half interest in the PATENTS and all rights associated with them; that ASSIGNOR has granted no licenses, exclusive or nonexclusive, other than to ASSIGNEE, to use the PATENTS or any rights associated with each of them, and that the within assignment will not violate or impair the rights of any third-party. ASSIGNOR shall indemnify and hold ASSIGNEE harmless against any third-party claims asserted against ASSIGNEE the subject matter of which shall be the within assignment or ASSIGNEE's use and/or licensing of the PATENTS or any rights associated with each of them.

3. ASSIGNEE shall record this AGREEMENT with the United States Patent and Trademark Office, all costs to be borne by ASSIGNEE. ASSIGNOR agrees to sign any additional documents and otherwise cooperate with ASSIGNEE as may be required to perfect the transfer of rights under this AGREEMENT. ASSIGNOR shall promptly obtain any assignments or other agreements from any third parties who may be shown as record owners of the Patents in order to insure that full ownership is transferred to ASSIGNEE.

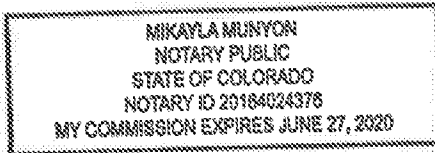

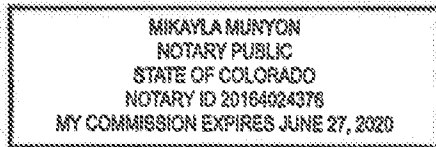



