**TRANSFER STATEMENT PURSUANT

SECTION 9-619 OF THE UNIFORM COMMERCIAL CODE**

Pursuant to Section 9-619 of the Uniform Commercial Code of the State of New York and the Uniform Commercial Code of the State of Illinois, the undersigned Secured Party (as defined below), under a Security and Pledge Agreement (the "Security Agreement") dated as of November 13, 2013, as amended, made by VeriTeQ Corporation, a Delaware corporation (the "Debtor"), VeriTeQ Acquisition Corporation, a Florida corporation ("Acquisition"), and PositiveID Animal Health Corporation, a Florida corporation ("PositiveID"), in favor of Magna Equities I, LLC, a Delaware limited liability company, in its capacity as successor Collateral Agent (the "Secured Party"), hereby states as follows:

1. The Debtor, Acquisition and PositiveID defaulted in connection with obligations secured under the Security Agreement by the following specified collateral (collectively, the "Collateral"): all personal property and assets of each of the Debtor, Acquisition and PositiveID other than Excluded Collateral (as defined below). The term "Excluded Collateral" means: (i) the capital stock of the Excluded Subsidiaries (as defined below); and (ii) all personal property and assets of the Excluded Subsidiaries. The term "Excluded Subsidiary" means VTQ IP Holding Corporation, ThermoLife Energy Corp., Signature Industries Limited and Keyswitch Varley Limited.
2. The Secured Party has exercised its post-default remedies with respect to the Collateral.
3. By reason of said exercise of post-default remedies, the Transferee identified below has acquired the rights of each of the Debtor, Acquisition and PositiveID in the Collateral.
