Assignee is authorized to make application for and to receive the Patent for said invention in any of said countries at its election.

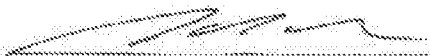

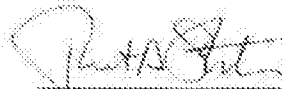

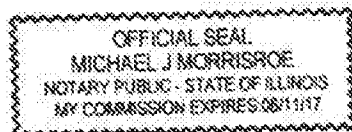
