ASSIGNMENT OF INVENTION

WHEREAS, I, **HUANG, Mingde**, NO. 18, SOUTH CHANGJIANG ROAD, NEW DISTRICT, WUXI, JIANGSU 214028, CHINA; **TANG, Yusheng**, NO. 18, SOUTH CHANGJIANG ROAD, NEW DISTRICT, WUXI, JIANGSU 214028, CHINA; and **KIM, Kyunghag**, NO. 18, SOUTH CHANGJIANG ROAD, NEW DISTRICT, WUXI, JIANGSU 214028, CHINA, have invented certain new and useful improvements in a **FRONT-LOADING WASHING MACHINE**, for which an application for Letters Patent in the United States was filed on November 1, 2016 and Assigned U.S. Application No. 15/340,267, claiming priority to Chinese Patent Application No. 201620086082.0 filed on January 28, 2016; and Chinese Patent Application No. 201610059066.7 filed on January 28, 2016.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said **WUXI LITTLE SWAN CO., LTD.** as the assignee of my whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid improvements, as the assignee thereof shall hereafter require and prepare at its own expense.


