

Whereas Daniel Diotte, hereinafter referred to as "assignor," whose mailing address is 1780 Liatris Drive, Pickering, ON Canada L1X 0B2, hereinafter referred to as Applicant, have invented certain new and useful improvements in night light wall socket covers for which a U.S. utility application was filed on April 5, 2013, Application Number 13/821,366, claiming priority on U.S. Provisional Application Number 61/380,561 filed on September 7, 2010. Whereas, VenMill Industries, hereinafter referred to as "assignee," whose mailing address is 36 Town Forest Road, Oxford, MA 01540 is desirous of acquiring the entire right, title and interest in the same:
