RELEASE OF PATENT SECURITY AGREEMENT

THIS RELEASE dated as of November 7, 2016 (this "Release") is made by OBSIDIAN AGENCY SERVICES, INC., a California corporation, acting in its capacity as collateral agent (in such capacity, the "Agent") under that certain Intellectual Property Security Agreement, dated as of August 6, 2014 (as amended, supplemented or modified and in effect from time to time, the "Agreement") by and among RIGHTSIDE OPERATING CO., a exempted Delaware corporation (the "Debtor") and the Agent.

WHEREAS, pursuant to the Agreement which was recorded in the records of the United States Patent and Trademark Office on August 7, 2014 at Reel 033498, Frame 0848 the Debtor granted to the Agent a continuing security interest in all of the Debtor's right, title and interest in, to and under its owned or thereafter acquired patents, including those set forth on the attached Schedule A (the "Patent Collateral");

WHEREAS, the Debtor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Patent Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral.
