## ASSIGNMENT OF PATENTS

This Agreement is by and between VSM GROUP AB, a Swedish corporation having a place of business at Drottninggatan 2, SE-56184 Huskvarna, Sweden (hereinafter "Assignor") and SINGER SOURCING LIMITED LLC, a Delaware limited liability company, having its principal place of business at 1224 Heil Quaker Boulevard, Laverne, Tennessee 37086 (hereinafter "Assignee").

WHEREAS, Assignor owns certain patent assets based on a patent application relating to inventions arising out of Assignor's business, which patent assets are described in U.S. Non-Provisional Patent Application Number 14/206,806, filed March 12, 2014, titled "VARIABLE SYSTEM FOR A SEWING MACHINE AND METHOD FOR SELECTIVELY ADJUSTING A TIMING OF SUCH A SYSTEM" (Attorney Docket Number: V2036-701410);

WHEREAS, Assignor and Assignee both desire that the entire right, title and interest in said application and inventions, and to any United States and foreign patents to be obtained therefore, be assigned to Assignee so that such assignment can be recorded in order that such assets can be registered in the name of Assignee, and thereby reflect Assignee's ownership thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor grants and assigns unto Assignee its entire right, title, and interest in and to said application for United States Letters Patent, any and all other applications for Letters Patent on said inventions in the United States and in countries foreign to the United States, including but not limited to any and all divisional, renewal, extension, reexamination, substitute, continuation, continuation-in-part, reissue, and Convention applications based in whole or in part upon said inventions or upon said applications, and any and all Letters Patent and reissues and extension of Letters Patent granted for said inventions or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said applications and said Letters Patent;

Assignee also hereby acquires the right, power, and authority to file and prosecute the Patents in its own name, wherever such right may be legally exercised, including the right to claim the priority and benefits of the Paris Convention Treaty, the Patent Cooperation Treaty, and all other international conventions and treaties. Assignor further assigns to Assignee, its successors and assigns, the right to bring actions for infringement of any right in the Patents in its own name, including past infringement, in any jurisdiction, and any and all claims for damages by reason of past and continuing infringement of the Patents.


