and to any and all divisions, reissues, continuations, conversions and extensions thereof for the full term or terms for which the same may be granted.

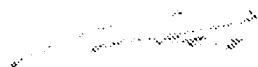

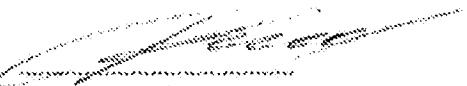

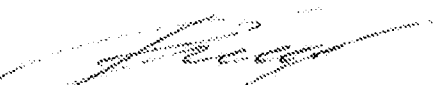
