In the event that ASSIGNEE is unable for any reason, after reasonable effort, to secure my signature on any document needed in connection with the actions specified in this paragraph, or to otherwise perfect in ASSIGNEE the entire right, title, and interest in and to the invention(s), ASSIGNOR hereby irrevocably designates and appoints the ASSIGNEE and its duly authorized officers and agents as my agent and attorney in fact, to act for and in my behalf to execute, verify and file any such documents and to do all other lawfully permitted acts to further the purposes of this assignment with the same legal force and effect as if executed by me. ASSIGNOR hereby waives and quitclaims to the ASSIGNEE any and all claims, of any nature whatsoever, which ASSIGNOR now or may hereafter have for infringement of any proprietary rights assigned to the ASSIGNEE, including the right to sue and collect damages from such infringement.

If any provision of this assignment is held by any court to be unenforceable, such provision shall be interpreted to accomplish the objectives of the original provision to the fullest extent allowed by law, and the remainder of this assignment shall remain in full force and effect.

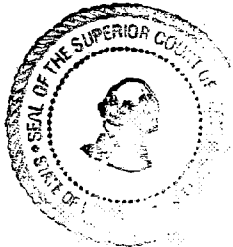


