TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN PATENTS

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS (this "Termination"), is dated as of November 15, 2016, and made by Goldman Sachs Lending Partners LLC, as the administrative agent, having an office at 200 West Street New York, New York 10282-2198 (the "Administrative Agent") to Contech Engineered Solutions LLC, an Ohio limited liability company, Keystone Retaining Wall Systems LLC, a Minnesota limited liability company, and Imbrium Systems LLC, a Delaware limited liability company (each, a "Grantor" and collectively, the "Grantors"). Unless otherwise defined herein, capitalized terms used herein shall have the same meanings ascribed to them in the Security Agreement (as defined below).

WHEREAS, pursuant to the Security Agreement between, among others, the Administrative Agent and the Grantors, dated as of June 13, 2013 (as the same may have been amended, modified, extended, or restated from time to time, the "Security Agreement"), each Grantor granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a continuing security interest in and continuing Lien upon (the "Security Interest") its patents and patent applications listed on Schedule A hereto (the "Patent Collateral");

WHEREAS, notice of the Security Interest in the Patent Collateral was recorded in the Assignment Division of the United States Patent and Trademark Office on June 18, 2013, at Reel 030634 and Frame 0040; and


WHEREAS, the Administrative Agent now desires to terminate and release the Security Interest in the Patent Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges its Security Interest in the Patent Collateral, and hereby reassigns to each Grantor, as applicable, any right, title, or interest it may have in the Patent Collateral of such Grantor, without recourse or representation or warranty, express or implied, of any kind.
