DEED OF ASSIGNMENT

THIS DEED OF ASSIGNMENT is made the 24th day of Dec., 2016

PARTIES:

E. The following terms of assignment have been agreed.

AGREED TERMS:

1. In consideration of the sum of £10 paid by CUSL to Joanne Wilkins
(the receipt of which Joanne Wilkins acknowledges), Joanne Wilkins
assigns all property right title and interest in and to the Inventions, the
Patent Applications, the Patents, and all other intellectual property
rights in or to the Inventions in all countries throughout the world to
CUSL absolutely together with all rights of action powers and benefits
belonging or accrued to the same in all countries, including the right to
claim and recover relief in respect of all infringements of the Patent
Applications, the Patents, and all other intellectual property rights in
or to the Inventions in all countries throughout the world arising prior
to the date of the assignment from Joanne Wilkins to CUSL, and
including the rights to all continuation, continuation-in-part, and
divisional patent applications, and any reissues, based on the Patent
Applications, the Patents, and all other intellectual property rights in
or to the Inventions in all countries throughout the world along with the
right to claim priority from the Patent Applications, the Patents, and


all other intellectual property rights in or to the Inventions in all countries throughout the world.

3. This Deed of Assignment is governed by and is to be construed in accordance with the laws of England and Wales.






