ASSIGNMENT AGREEMENT

1.2 in respect of any and each application in the PATENTS:

1.2.1 the right to claim priority from and to prosecute and obtain grant of patent on such application; and

1.2.2 the right to file divisional applications based thereon and to prosecute and obtain grant of patent on each and any such divisional application;

1.3 in respect of each and any invention disclosed in the PATENTS, the right to file an application, claim priority from such application, and prosecute and obtain grant of patent or similar protection in or in respect of any country or territory in the world;

1.4 the right to extend to or register in, or in respect of, any country or territory in the world each and any of the PATENTS, and each and any of the applications filed as aforesaid, and to extend to or register in or in respect of any country or territory in the world any patent or like protection granted on any of such applications;

1.5 the absolute entitlement to any patents granted pursuant to any of the applications filed as aforesaid; and

1.6 the right to bring, make, oppose, or defend any appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the PATENTS




or any patents granted on any of the applications filed as aforesaid, whether occurring before, on or after the date of this assignment.

1.7 The ASSIGNOR hereby authorizes and requests the relevant patent officer/commissioner whose duty it is to issue patents on applications as aforesaid (including, where relevant, the Commissioner of Patents of the United States) to issue all letters patent for the said invention to the ASSIGNEE in accordance with the terms of this assignment.

1.8 The ASSIGNOR represent(s) and covenant(s) that the ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith.

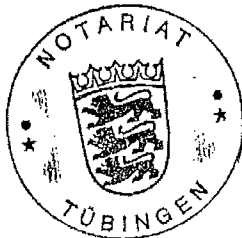
