### **SUPPLEMENTAL ASSIGNMENT**

WHEREAS, this Supplemental Assignment supplements the previous Assignment between Johnny J. Kent and ColorZen LLL, executed on August 15, 2014 and August 19, 2014 respectively, to set forth the application number for the PCT Application.

WHEREAS, Johnny J. 


