ASSIGNMENT OF INVENTION AND PATENT RIGHTS





Bernstein, or his designee, to execute on my behalf any documents necessary to evidence authorship, inventorship or invention ownership (including declarations) and assignments granted herein for the United States or any other country without further notice to me and to fill in the application number and filing date above when obtained, even if after execution of this Agreement.

And I do hereby authorize and request the Commissioner for Patents of the United States to issue such Letters Patent as shall be granted upon said application or applications based thereon to Assignee, its successors and assigns.
