ASSIGNMENT

WHEREAS, I, Nazir Mir, a citizen of the United States of America, (hereinafter referred to as "ASSIGNOR"), have invented a certain invention entitled ACTIVE COMPOUND FORMULATION PACKAGE AND ITS SUBSEQUENT RELEASE FOR USE ON PLANT AND PLANT PARTS, for which U.S. Patent Application Serial No. US 13/969,393 ("393 application"), publication No. US20140326620 A1 was filed on August 16, 2013; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over unto ASSIGNEE, its successors and assigns, the full and exclusive right, title and interest to the invention, to the '393 application and to all patents or similar legal protection, in the United States, its territorial possessions and in any and all countries foreign thereto, to be obtained for the invention, from the '393 application, and to any continuation, continuation-in-part, division, renewal, substitute, reexamination or reissue thereof or any legal equivalent thereof in the United States, its territorial possessions or a foreign country for the full term or terms for which the same may be granted, including the right to file and prosecute any and all such applications or legal equivalents, including the right to sue and recover for any and all such applications or legal equivalents and the right to enforce all claims and recover damages for any and all infringements, and including all priority rights under the International Convention; and ASSIGNOR hereby authorizes and requests the United States Commissioner of Patents and Trademarks

and any officials of foreign countries whose duty it is to issue patents or legal equivalent thereof, to issue said patents or any legal equivalent thereof to ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into, nor any act performed, which would conflict with this Agreement.

ASSIGNOR further covenants that upon ASSIGNEE's request, ASSIGNOR will promptly provide ASSIGNEE with all pertinent facts and documents relating to the invention, the '393 application and any related applications and legal equivalents as may be known and accessible to ASSIGNOR, will testify as to the same in any litigation or Patent Office or other proceeding related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce the invention, the '393 application, and any related applications and legal equivalents in the United States, its territorial possessions or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
