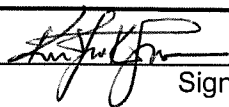

This RELEASE OF SECURITY INTEREST IN PATENTS (this “Release”), dated as of December 1, 2016 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as successor to the Original Collateral Agent (as defined below) (the “Collateral Agent”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain U.S. Pledge and Security Agreement, dated as of February 8, 2013, by and among Goldman Sachs Bank USA (the “Original Collateral Agent”), the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Pledge and Security Agreement”), each of the Grantors granted to the Original Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Pledge and Security Agreement, each of the Grantors executed and delivered a Confirmatory Patent Security Agreement, dated as of November 13, 2013 (the “Patent Security Agreement”), to the Collateral Agent, for recordal with the United States Patent and Trademark Office;

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on November 15, 2013 at Reel/Frame 031644/0814;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Pledge and Security Agreement or the Patent Security Agreement, as applicable.

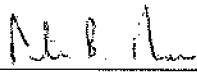
2. Release. The Collateral Agent, without representation or warranty of any kind, and as successor to the Original Collateral Agent, hereby releases, discharges, terminates and cancels all of its security interest in and to the Patent Collateral, including the patents and patent applications set forth Schedule A attached hereto, arising under the Pledge and Security Agreement and the Patent Security Agreement. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Patent Collateral under the Patent Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.

3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Patent Security Agreement.

4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to each of the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors’ sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
