**ASSIGNMENT**

This Assignment is made and entered into by and between **(1) James M. 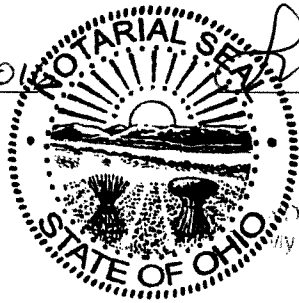

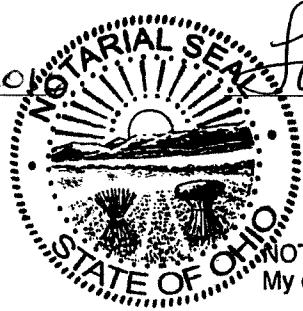
