This is a patent and patent application assignment (the "Assignment") by and between the below parties with an effective date as of November 28, 2016.

WHEREAS, **BLUEPRINTER APS**, a company formed under the laws of Denmark, with its principal place of business at **Nørrebrogade 14b, 3, DK-2200 Copenhagen N, Denmark**, is the owner of the patents and patent applications identified in the attached Schedule A, and all corresponding patent applications and patents and patents filed or granted thereon in any country of the world;

WHEREAS, Blueprinter ApS was declared bankrupt on September 1, 2016, and Nicolai Dyhr was appointed trustee of **Blueprinter ApS in Bankruptcy** (hereinafter referred to as "Assignor");

WHEREAS, **HEWLETT-PACKARD DEVELOPMENT COMPANY, L.P.**, a limited partnership established under the laws of the State of Texas and having a principle place of business at **11445 Compaq Center Drive West, Houston, Texas 77070, U.S.A.** (hereinafter "Assignee"), desires to acquire Assignor's entire right, title and interest, including the right of priority, in, to and under the patents and patent applications identified in the Schedule A and all corresponding patent applications and patents filed or granted thereon in any country of the world; and

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, Assignor and Assignee agree as follows.

Assignor assigns, transfers, conveys and delivers to Assignee the entirety of Assignor's right, title and interest, including, without limitation, the right of priority, in the patents and patent applications identified in the Schedule A, and the inventions and improvements set forth therein, including any corresponding patent applications, including, without limitation, provisional applications, priority applications, and patents filed or granted in any country of the world, and also including any continuations, continuations-in-part (CIP's), divisionals, renewals, or substitutes thereof, and any reissues, or reexaminations, or extensions thereof (collectively referred to as "Patents"). Assignee shall have the right to sue, counterclaim and recover for past, present, and future infringement and collect all past, present, and future royalties, damages, or other income relating to such Patents.

In connection with the foregoing, Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and/or the appropriate empowered officials in jurisdictions outside the United States to record the transfer of the Patents to Assignee as assignee of Assignor's right, title and interest therein, and to issue to Assignee all letters patent and other items referred to above which may issue with respect to the Patents in and outside the United States.

IN WITNESS WHEREOF, Assignor and Assignee have caused this Assignment to be executed by their authorized representatives. Each such authorized representative hereby declares that all statements made herein of his or her own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under section 1001 of Title 18 of the United States Codes and that such willful false statements may jeopardize the validity of any patents related thereto.
