
ASSIGNMENT

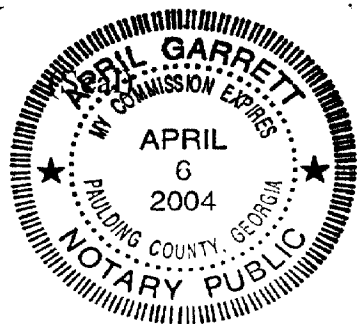

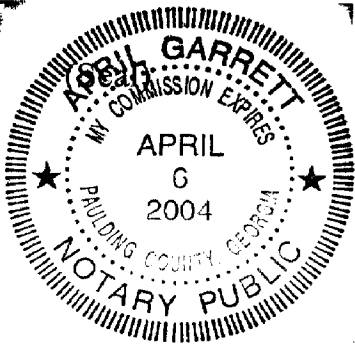

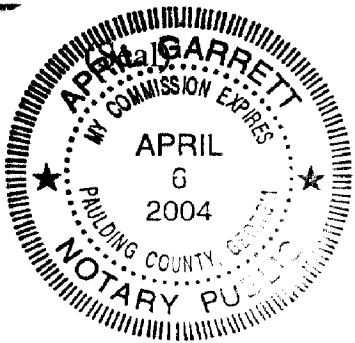
