PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT (this “**Release**”) is made as of November 22, 2016, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Notes Collateral Agent (“**Collateral Agent**”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Patent Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, ASSOCIATED MATERIALS, LLC, a Delaware Limited Liability Company (“**Grantor**”), and the Collateral Agent are parties to that certain Notes Security Agreement dated as of October 13, 2010 (the “**Security Agreement**”), whereby the Grantor granted to the Collateral Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under certain Patents (as defined below) as security for certain obligations owing by Grantor to the Collateral Agent, including, without limitation, the Patents set forth on Schedule A hereto (the “**Collateral**”);

WHEREAS, Grantor is party to that certain Grant of Security Interest in Patent Rights, dated as of October 13, 2010 (the “**Patent Security Agreement**”), pursuant to which Grantor granted to the Collateral Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under the Collateral;

WHEREAS, the Patent Security Agreement was recorded by the United States Patent and Trademark Office on November 9, 2010, at Reel 025326, Frame 0586;

WHEREAS, Grantor has requested that Collateral Agent, and Collateral Agent now desires to, terminate and release its continuing security interest in the Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby automatically and unconditionally releases and terminates its continuing security interest in all of Grantor’s right, title and interest in the Collateral.

2. Collateral Agent hereby terminates the Patent Security Agreement and fully and finally terminates, discharges, releases, cancels, reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent’s right, title and interest in and to the Collateral.

3. Collateral Agent agrees to execute further papers (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) and to do such other acts as may be necessary or requested by the Grantor to effect the release of the security interest

contemplated hereby, in each case at the sole cost of Grantor, who shall promptly reimburse Collateral Agent for all costs and expenses incurred by Collateral Agent in connection with the foregoing.

4. Collateral Agent hereby authorize the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry.
