### PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT ("Release") is made as of December 29, 2016, by ANTARES CAPITAL LP, acting in its capacity as successor to General Electric Capital Corporation, as Administrative Agent ("Secured Party") in favor of Hilex Poly Co. LLC, Duro Hilex Poly, LLC and PDOC, LLC (each a "Grantor", and collectively, the "Grantors").

WHEREAS, pursuant to that certain Patent Security Agreement by and between Secured Party and Grantors dated as of December 5, 2014 (the "Security Agreement") Grantors granted to Secured Party a security interest in and to all of the right, title, and interest of each Grantor in, to and under the Patent Collateral (as defined below);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on December 10, 2014, at Reel 34587, Frame 0595; and

WHEREAS, the Grantors have requested that the Secured Party enter into this Release in order to effectuate, evidence and record the release and reassignment to each Grantor of any and all right, title and interest the Secured Party may have in the Patent Collateral (as defined below) pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates, cancels, releases and discharges any and all security interests it has pursuant to the Security Agreement in any and all right, title, and interests of each Grantor, and reassigns to each Grantor any and all right title and interest that it may have in, to and under the following (collectively the "Patent Collateral");
  - (a) any and all patents, patent applications and other patent rights and any other governmental authority-issued indicia of invention ownership, including the patents and patent applications listed in Schedule I hereto, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions and reexaminations thereof and amendments thereto (the "Patents");
  - (b) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;
  - (c) any and all license and other agreements in which such Grantor has granted or is granted a license or other right under any Patent;
  - (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights but no obligation to sue and recover damages at law or in equity for any past, present and future infringement, misappropriation, violation or other impairment thereof.
2. Secured Party agrees, at Grantors' expense, to take all further actions, and provide to the Grantors and their respective successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantors and their respective successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. All capitalized terms used, but not expressly defined in this Release have the meanings given to them in the Security Agreement.
