PATENT SECURITY AGREEMENT, dated as of December 31, 2016 (this "Agreement"), between HEXION INC. (formerly MOMENTIVE SPECIALTY CHEMICALS INC.), a New Jersey corporation (the "Pledgor") and WILMINGTON TRUST, NATIONAL ASSOCIATION, as collateral agent (the "Collateral Agent") under the Security Agreement referred to below.

Reference is made to the Collateral Agreement dated as of March 28, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Hexion U.S. Finance Corp. ("Hexion Finance"), the Pledgor, each subsidiary of the Pledgor listed therein and the Collateral Agent. The Pledgor and Wilmington Trust, National Association have entered into the Indenture dated as of March 14, 2012 (as supplemented by the First Supplemental Indenture, dated as of January 31, 2013, and the Second Supplemental Indenture, dated as of March 28, 2013, and as further amended, restated, supplemented or otherwise modified from time to time, the "Indenture"), among Hexion Finance, as issuer, the Pledgor, the other subsidiaries of the Pledgor as guarantors from time to time party thereto and Wilmington Trust, National Association, as trustee.

The parties hereto agree as follows:

SECTION 1. <u>Terms.</u> Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement or, if not defined therein, in the Indenture. The rules of construction specified in Section 1.01(b) of the Security Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance when due, as the case may be, in full of the Obligations, the Pledgor, pursuant to the Security Agreement, hereby grants to the Collateral Agent, its successors and permitted assigns, for the ratable benefit of the Secured Parties, a security interest in all right, title and interest in or to any and all Patents now owned or at any time hereafter acquired by the Pledgor or in which the Pledgor now has or at any time in the future may acquire any right, title or interest, including those listed on Schedule I (collectively, the "Patent Collateral").

SECTION 3. Security Agreement. The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Security Agreement. The Pledgor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Patent Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. <u>Governing Law</u>. This Agreement and the rights and obligations of the parties under this Agreement shall be construed in accordance with and governed by the laws of the State of New York.
