The Assignors hereby covenant that they: have full right to convey the entire interest herein assigned; and have not executed and will not execute any agreement to transfer any rights in the Inventions and/or the Applications to anyone other than the Assignee or that is otherwise in conflict herewith.

The Assignors promise that they shall:


all at the expense, however, of the Assignee or its successors, assigns, nominees or legal representatives.




