ASSIGNMENT

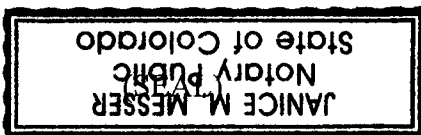


