2. Assignor hereby covenants and agrees to cooperate with Assignee to enable Assignee to enjoy to the fullest extent the right, title, and interest to the assigned subject matter, applications, and patents herein conveyed in any and all countries and groups of countries. Such cooperation by Assignor shall include prompt production of pertinent facts and documents, giving testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by Assignee (a) for perfecting in Assignee the right, title, and interest herein conveyed; (b) for prosecuting any of said applications; (c) for filing and prosecuting substitute, divisional, or continuation applications based on or claiming priority to any of said applications; (d) for filing and prosecuting applications for reissuance of any of said patents; (e) for interference or other priority proceedings involving any of said applications; and (f) for legal proceedings involving said applications, and any patents granted thereon including, without limitation, opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions, and court actions provided that the expense incurred by Assignor in providing such cooperation shall be paid for by Assignee.

3. The term and covenants of this agreement shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, his respective heirs, legal representatives, and assigns.

4. Assignor hereby warrants and represents that he has not entered and will not enter into any assignment, contract, or understanding in conflict herewith.


