RELEASE OF SECURITY INTERESTS IN PATENTS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS (this “Release”), dated as of January 20, 2017, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, “Agent”), in favor of HEAT SOFTWARE USA INC., a Colorado corporation formerly known as FrontRange Solutions USA Inc. and successor in interest to FrontRange Solutions Inc. (as “Grantor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Patent Security Agreement (as defined below).

A. WHEREAS, the Grantor has, pursuant to that certain Patent Security Agreement dated February 19, 2015, recorded in the United States Patent and Trademark Office (the “USPTO”) on February 28, 2015 at Reel 035111, Frame 0412 (as the same may be amended, amended and restated, restated, supplemented, modified, or otherwise in effect prior to the date hereof, the “Patent Security Agreement”) granted to Agent (for the benefit of each member of the Lender Group and the Bank Product Providers) a Security Interest in and to all of the Grantor’s right, title and interest in and to the Patent Collateral, including without limitation those patents listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and


B. WHEREAS, Agent, on behalf of each member of the Lender Group and the Bank Product Providers, wishes to release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of each member of the Lender Group and the Bank Product Providers, hereby releases, without representation or warranty, its Security Interest in and to the Released Collateral and terminates the Patent Security Agreement. Agent acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Agent authorizes the Grantor to record this Release with the United States Patent and Trademark Office and other applicable registry at the sole expense of the Grantor and agrees to provide Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
