ASSIGNMENT

This Assignment is made as of January 19, 2017, by Tariq Quadir (the "Inventor"), and Superior Technical Ceramics Corporation, a Vermont corporation with a place of business at 600 Industrial Park Road, St. Albans, Vermont (the "Assignee").


proceedings involving the U.S. and foreign applications and patents as oppositions, cancellation proceedings, priority contests, interferences, public use proceedings, court actions, and the like.


