Assignor also hereby sells and assigns to Assignee, its successors and assigns, all foreign rights to the Patent Rights, in all patent-granting countries of the world, including the right to file applications and obtain patents in its own name in said countries, including all rights of priority under the terms of the International Convention for the Protection of Industrial Property, and further agrees at Assignee's expense to execute any and all patent applications, assignments, affidavits, and any other papers in connection therewith necessary to perfect such Patent Rights.

Assignor hereby covenants and agrees that, at the time of execution and delivery of this instrument, it is the lawful owner of the complete right, title and interest in and to the Patent Rights and its interest is unencumbered and that it has good and full right and lawful authority to sell and convey its interest in the manner set forth herein.

Assignor hereby further agrees at the request and expense of Assignee, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue and reexamination applications, make all lawful oaths, and generally do everything possible within reason to aid Assignee, its successors, assigns and representatives to obtain proper patent protection for and enforce said Patent Rights in all countries.

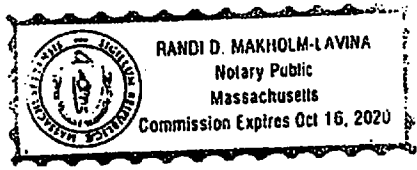
