## RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST, dated as of January 26, 2017 (the "Release"), is executed by William G. Love in his capacity as Treasurer of Eastman Kodak Company, a New Jersey corporation ("Kodak" or "Grantor"). Capitalized terms used but not defined herein have the respective meanings given to them in the Credit Agreement or Security Agreement, as such agreements are defined below.

WHEREAS, Kodak entered into an Amended and Restated Credit Agreement, dated as of May 26, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), with the Lenders party thereto and Bank of America, N.A., as Administrative and Collateral Agent for the Lenders (the "Lienholder"); and

WHEREAS, as a condition precedent to the obligation of the Lender Parties to make their respective extensions of credit to Kodak under the Credit Agreement, Kodak executed and delivered to the Lienholder an Amended and Restated Security Agreement, dated May 26, 2016, which amended and restated the Security Agreement from Kodak to the Lienholder dated September 3, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"); and

WHEREAS, under the terms of the Security Agreement, Kodak as the Grantor granted the Lienholder, for the ratable benefit of the Secured Parties, a security interest in the US patents listed in Schedule A attached hereto (the "Purchased Patents"), which security interest was evidenced by an Intellectual Property Security Agreement dated September 3, 2013 and recorded in the USPTO on reel 031162 frame 0117; and

WHEREAS, Kodak entered into a Patent Sale Agreement, dated December 30, 2016, with CloudeTV, Inc., a company incorporated under the laws of Delaware (the "Buyer"), pursuant to which Buyer acquired, among other assets, the Purchased Patents; and

WHEREAS, under Section 25 of the Security Agreement upon any Disposition of any item of Collateral of any Grantor, the security interests granted under the Security Agreement by such Grantor in such Collateral shall immediately terminate and automatically be released;

NOW THEREFORE, the undersigned asserts that he is authorized to sign this Release of Security Interest on behalf of Eastman Kodak Company and hereby affirms that upon the Disposition of the Purchased Patents, the security interest of the Lienholder therein automatically terminated and was released pursuant to Section 25 of the Security Agreement.
