Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Patent.

Assignor shall, at the request and expense of Assignee, take all further actions and provide to Assignee, its successors, assigns and other legal representatives, all such cooperation and assistance (including, without limitation, the timely execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney and other documents and instruments) and do all other things, deemed necessary, proper or advisable by Assignee to establish and perfect Assignee's proprietary right, title and interest in the Patent and more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to: (i) the recordation or perfection of this Assignment in all applicable jurisdictions throughout the world; (ii) the preparation and prosecution of any applications covering the inventions assigned herein; (iii) the prosecution or defense of any interference, opposition, reexamination, reissue, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to any of the rights assigned herein and this Assignment; and (iv) obtaining any additional patent protection relating to any of the rights assigned herein that may be secured under the laws now or hereafter in effect in the United States or in any other country.

Where Assignee is unable because of Assignor's unavailability, dissolution, mental or physical incapacity, or for any other reason, to secure Assignor's signature to apply for or to pursue any application for any United States or foreign patent covering or claiming priority to the Patent, then Assignor hereby irrevocably designates and appoints Assignee and Assignee's duly authorized officers and agents as Assignor's agent and attorney-in-fact, to act for and in Assignor's behalf and stead to execute and file any such applications and to do all other lawfully permitted acts to further a prosecution and issuance of patents thereon with the same legal force and effect as if executed by Assignor (which designation and appointment shall be deemed coupled with an interest).

This Assignment may be executed in counterparts, each of which shall be deemed an original and all of which shall together constitute one and the same instrument, and shall become effective when one or more counterparts have been signed by any Assignor and delivered to Assignee. Delivery of an executed signature page to this Assignment by facsimile or other electronic transmission shall be as effective as delivery of a manually executed counterpart to this Assignment.

Assignor hereby irrevocably waives all right to a trial by jury in any action, proceeding or counterclaim arising out of or relating to this Assignment. Assignor hereby expressly recognizes the doctrine of assignor estoppel and shall not challenge the legality, validity, enforceability, use, inventorship or ownership of the Patent.

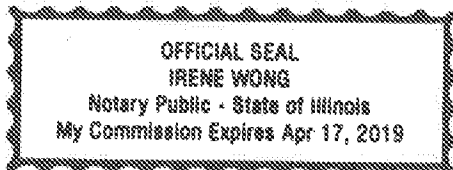



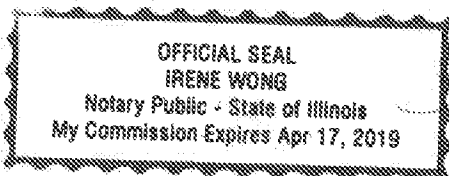
