ASSIGNMENT OF PATENTS

Further, Lacey represents that it has not made, and covenants with Mini-Lap, its successors, assigns, and transferees that it will not hereafter make, any assignment, grant, mortgage, license, or other agreement affecting the rights, titles, and interests in the Patents. Lacey further covenants that it has the full right to convey the rights, titles, and interests assigned by this Assignment.

Lacey further agrees to: (a) cooperate with Mini-Lap in the protection of the Patent rights and prosecution and protection of foreign counterparts; (b) execute, verify, acknowledge and deliver all such further papers, including patent applications and instruments of transfer; and (c) perform such other acts as Mini-Lap lawfully may request to obtain or maintain the Patents and any and all applications and registrations for the invention in any and all countries; provided Lacey is reimbursed by Mini-Lap for all reasonable expenses in such actions. Lacey hereby authorizes and requests the Commissioner of Patents and any official of any foreign country to issue any and all Letters Patent which may be granted upon any of the foregoing, to Mini-Lap (or, as relevant, its legal representative, successors, assigns or nominees) as the assignee of the entire interest therein.

Therefore, for valuable consideration including payment in the amount of ten dollars (\$10.00), the receipt of which is hereby acknowledged, Lacey assigns, sells and transfers all of Lacey's right, title and interest in the Patents to Mini-Lap, its successors and assigns for the entire term of the Patents and for the entire terms of any patents, reissues or extensions that may issue from foreign applications, divisions, continuations in whole or part or substitute applications filed claiming the benefit of any of the Patents. The right, title and interest conveyed in this Assignment are to be held and enjoyed by Mini-Lap and Mini-Lap's successors as fully and exclusively as it would have been held and enjoyed by Lacey had this Assignment not been made.
