ASSIGNMENT OF INTELLECTUAL PROPERTY AGREEMENT

THIS AGREEMENT made the 15th day of January, 2017.

BETWEEN:

VEROLUBE INC., an Alberta corporation, having its registered office

(the "Assignor")

AND:

PNG GOLD CORPORATION, a British Columbia company having its
office at Suite 600-1090 Pender Street, Vancouver, British Columbia
V6E 2N7

(the "Assignee")

WHEREAS:

A. The Assignor is the owner of certain patents (the "Registered Patents"), patent applications (the "Applied for Patents") both Registered Patents and Applied for Patents as described in Schedule "A" hereto as well as all rights to the invention(s) underlying the Registered Patents and the Applied for Patents (collectively, the "Patents").

B. The Assignor wishes to assign to the Assignee, any and all rights the Assignee may have in and to the Patents pursuant to the terms and conditions of this Agreement.


NOW THEREFORE in consideration for ten Canadian dollars (\$10 CAD) of the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by each of the parties, it is agreed between the parties hereto as follows:

1. Assignment

The Assignor hereby irrevocably conveys, transfers and assigns to the Assignee:

- a) all of the Assignor's right, title and interest in and to the Patents and all issuances, extensions and renewals thereof; and
- b) all rights of any kind whatsoever of the Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world.

For certainty, in the event that any of the Applied for Patents listed in Schedule "A" for which the status is "unknown" to the assignee at this point in time, has been abandoned, the above assignment includes all rights to pursue revival of such Applied for Patents.

2. Assignor's Representations and Warranties:

The Assignor hereby represents and warrants:

- a) that it has the legal right and authority to execute this Agreement and to validly assign the entire right, title and interest in and to the Patents to the Assignee;
- b) that it has not executed any other agreement that conflicts with the terms of this Agreement, nor shall it execute any such agreement in the future;
- c) that to the best of the Assignor's knowledge, the Registered Patents are valid and enforceable as of the date of this Agreement; and
- d) that the Patents:
 - i. have not infringed, do not infringe and are not likely to infringe the intellectual property of any third party; and
 - ii. have not constituted, do not constitute and are not likely to constitute any breach of confidence, passing off or actionable act of unfair competition or other illegal acts in connection with the intellectual property of a third party.

3. Authorization of Assignment

The Assignor hereby authorizes and requests all applicable governing bodies, including but not limited to the World Intellectual Property Organization ("WIPO"), United States Patent and Trademark Office and the Canadian Intellectual Property Office, to assign the rights described in Section 1 of this Agreement.

4. Further Actions

The Assignor hereby agrees to execute any further agreements and to take any further actions as necessary to aid the Assignee in perfecting its interest in the Patents and in enforcing any and all protections, privileges, or rights deriving from the Patents.

5. Governing Law


