ASSIGNMENT

WHEREAS, Sebastiaan Adrianus Alphonsus Petrus Hoeksel, a citizen of the Netherlands, residing at Roserije 228C, 6118 DP Maastricht, the Netherlands, Johannes Jacobus Schreuder, a citizen of the Netherlands, residing at St. Antoniusstraat 9, 6268 NR Bemelen, the Netherlands, and Josef Reinier Cornelus Jansen, a citizen of the Netherlands, residing at Aster 8, 2211 MZ Noordwijkerhout, the Netherlands (hereinafter "the Assignors"), have invented a certain new and useful DEVICE FOR DETERMINING A CHARACTERISTIC POINT IN THE CARDIAC CYCLE for which an application for United States Letters Patent was filed on June 15, 1998 and assigned Application Serial No. 09/091,325 as a U.S. national phase application of PCT Application No. PCT/NL96/00490; and





Assignors further covenant to execute all additional instruments and to do all things necessary to carry out the purpose of this instrument at the expense of the Assignee and its successors.


