AND for the same consideration, Assignor, its successors, assigns, and other legal representatives, will cooperate with Assignee's requests to sign all papers and documents, take all lawful oaths, testify in all legal proceedings, sign and deliver all papers that may be necessary or desirable to perfect title to said Letters Patent, and do all acts necessary or

required to be done for the maintenance, enforcement and defense of said Letters Patent, whenever Assignee shall advise.

This Assignment constitutes the entire, full and complete agreement between the Parties concerning the subject matter hereof, and supersedes all prior agreements, negotiations, representations, and discussions written or oral, express or implied, between the Parties in relation thereto.

Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as owner of said Letters Patent.

This Assignment may be executed in any number of counterparts and by the separate Parties on separate counterparts, each of which when executed and delivered shall constitute an original, and all such counterparts together shall constitute but one and the same Assignment.
