Such appointment, coupled with an interest, is irrevocable by Assignors and shall not be revoked by Assignors' insolvency, bankruptcy, death or incapacity and Assignors hereby agree to ratify and confirm all that Assignee may do or cause to be done pursuant to the foregoing.

Assignors hereby authorize the Assignee, including its appointed Patent Agents, to amend this Assignment to insert or correct the filing date, serial number, or other identifying information of said Application(s) as may be needed to record same.

If any part of this Assignment shall be held by a court of competent jurisdiction to be void, invalid or inoperative, the remaining provisions of this Assignment shall not be affected and shall continue in effect, and the invalid provision shall be deemed modified to the least degree necessary to remedy such invalidity.


