

Assignor represents that it has not transferred, licensed or otherwise granted any rights of any kind in the invention(s), to any other party.

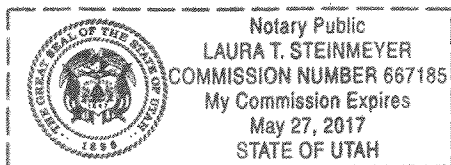


