AND we hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in the United States, Canada and throughout the world for any purpose and more particularly in proof of the right of said Assignee or nominees to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

AND we hereby covenant that we have the full right to convey the entire right, title and interest herein assigned and that we have not executed and will not execute any agreement in conflict herewith.

Further, we agree that we will communicate to said assignee or its representatives any facts known to me respecting said invention or inventions, and testify in any legal proceeding, sign all lawful papers, execute all papers relating to all continuations, divisions, continuations-in-part, extensions, non-provisionals, renewals or substitutes thereof, to all continuations, divisions, continuations-in-part, extensions, renewals and substitutes of any non-provisionals, and any reissues, reexaminations or extensions of said Letters Patents, execute any necessary assignment papers to cause any and all of said Letters Patents to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said Invention or inventions in United States, Canada and throughout the world.
