- Any and all other patents that may be or have been obtained for any of the designs disclosed in the Patents and/or Design Registrations in any and all countries;
- Any reissue, reexamination, extension, renewal, substitution, conversion, confirmation, division, continuation, nonprovisional, provisional, continuation-in-part and the like of any of the foregoing;
- Any application claiming priority to any of the foregoing;
- Any application from which any of the foregoing claims priority; and
- Any past or present right or cause of action arising with respect to any of the foregoing, including any right to sue for patent infringement, and any copyright in any embodiment of a Design and any derivative right thereof.

FURTHERMORE, Assignor hereby acknowledges that any and all Assigned Rights are, under separate agreement, already under obligation of assignment to Assignee and in fact may have already been assigned to Assignee, and that this Assignment is being duly executed for at least the purposes of public recordation with the USPTO, or any other intellectual property registration office throughout the world, of Assignee's rights, title, and interests in and to the Assigned Rights.

Effective with respect to the Patents and Design Registrations at least as early as the time of conception of each design disclosed therein, Assignor hereby authorizes and empowers Assignee to invoke and claim for any patent or registration included within the Assigned Rights the benefit of any rights to which Assignor might be entitled under international law or under the laws of any particular country, and to invoke and claim such rights without further written or oral authorization from any of the Assignor.

Assignor hereby consents and agrees that a copy of this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document that may be required in any particular country for any purpose and, more particularly, in proof of the right of Assignee to claim the aforesaid benefit of the right of priority and the right to file for patent.

Assignor covenants and agrees that this Assignment and all the terms thereof shall inure to the benefit of the successors, assigns, legal representatives, and nominees of Assignee, without further written or oral authorization from Assignor.

Assignor hereby represents and warrants that it is an original inventor or original joint inventor of the designs disclosed in the Patents and Design Registrations; and Assignor has reviewed and understood the contents of the Patents and Design Registrations identified above. Assignor hereby acknowledges that any willful false statement made in this declaration is punishable under 18 U.S.C. § 1001 by fine or imprisonment of not more than five (5) years, or both.

Finally, Assignor hereby authorizes and requests the Director of the United States Patent & Trademark Office to issue any design patent included within the Assigned Rights to Assignee.
