3. The foregoing amendment of Amended and Restated Articles of Incorporation has been duly approved by the corporation's Board of Directors.

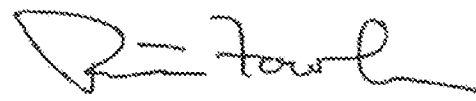
