SHORT-FORM PATENT SECURITY AGREEMENT

WHEREAS, SyferLock Technology Corporation, a Connecticut corporation (the "Grantor") has applied for letters patent and has been granted letters patents in the United States Patent and Trademark Office, and is the owner of the patent applications and patents listed in the attached Schedule of Patents and Patent Applications associated therewith;

WHEREAS, on August 25, 2009 the Grantor, as borrower, and Robert D. 
WHEREAS, in connection with the Security Agreement, the Grantor has agreed with the Lender to execute this Short-Form Patent Security Agreement; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Lender, to the extent provided in the Security Agreement (the terms and conditions of which are hereby incorporated herein), a security interest in all of its right, title and interest in to and under all the patents and patent applications whether now owned or at any time hereafter acquired, of the Grantor issued by, or for which applications have been filed with, the United States Patent and Trademark Office, including the patents and applications on the attached Schedule of Patents and Patent Applications, and all related patents and applications thereto, including all reissuances, continuations, continuations-in-part, revisions, extensions, re-examinations thereof, any patents and patent applications claiming priority to said patents and patent applications or from which said patents and patent applications claim priority; and pending applications associated therewith, as collateral security for the prompt and complete payment and performance when due of all obligations due and owing under the Security Agreement and related Amended Restated Note Purchase Agreement dated the date hereof. Notwithstanding the foregoing, in the event of any conflict between this Short-Form Patent Security Agreement and the Security Agreement, the Security Agreement shall control.

This Short-Form Patent Security Agreement shall be construed in accordance with and governed by the law of the State of New York, without regard to principles of conflicts of laws that would result in the application of the laws of any other jurisdiction.
