ASSIGNMENT

We also hereby sell, assign and transfer to the ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive right, title and interest to the inventions disclosed in the application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for the inventions in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of the inventions and all rights to register the inventions in appropriate registries; and we further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in the ASSIGNEE, its successors, assigns and legal representatives.


We hereby further agree that we will communicate to the ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to us respecting any improvements and, at the expense of the ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make all lawful oaths, and generally do everything possible to vest title in the ASSIGNEE and to aid the ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for the inventions in all countries.
