ASSIGNOR hereby authorizes and requests the issuing authority to issue any and all patents issuing from any of the foregoing to the ASSIGNEE or its successors and assigns. ASSIGNOR agrees that the attorney or agent of record in the ASSIGNED PATENTS shall cooperate on behalf of the ASSIGNEE for the sole purpose of changing representation and perfecting this Patent Assignment.


