**PATENT ASSIGNMENT**



Assignor hereby transfers and conveys to Assignee any right to recover for past and future infringement of the patents assigned herein.

Assignor HEREBY covenants and agrees that it will at any time, upon the request and at the expense of Assignee, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect the title to, enforce, and defend said inventions, applications and patents, and we authorize the Commissioner of Patents and Trademarks, or any other patent-issuing authority in the United States or any other country, to issue said patents to Assignee.
