



**DECLARATION OF DORON BESSER, MD**

I, the undersigned Doron Besser, MD, hereby declare and state as follows:

I, hold the position of Managing General Partner of NUTRISEAL LIMITED PARTNERSHIP, whose address is 7 Haarad Street, Tel Aviv, Israel.

The company completed a Change of Name to NUTRISEAL LIMITED PARTNERSHIP on December 25, 2014. Attached hereto is a copy of a Change of Name Certificate issued by the Ministry of Justice -- Corporations Authority, Registrar of Companies and Partnerships, along with an English translation thereof, showing that the former name of the company was TURBOSEAL LIMITED PARTNERSHIP and that the name had been changed to NUTRISEAL LIMITED PARTNERSHIP. The company and its street address in Tel Aviv, Israel, did not change; only the name was changed.

The inventors for the above-referenced application, Avinoam NEVLER, Orit SHAKED and Eyal HAYTMAN, assigned their rights to Turbo Seal L.P., of 7

Haarad Street, Tel Aviv, Israel, on July 28, 2013, and, on information and belief, this assignment was recorded at the U.S. Patent and Trademark Office on July 29, 2013. A copy of the originally recorded papers and the cover sheet are attached hereto.

It is clear that an inadvertent error occurred in setting forth the English form of the name of the company on the assignment document. The English form of the name of the organization was inaccurately presented as two words and with an abbreviation of the words "Limited Partnership." As can be seen from the attached Change of Name Certificate, the English form of the name of the organization prior to December 25, 2014, was technically "TURBOSEAL LIMITED PARTNERSHIP."


I hereby attest that the minor difference in the form of the name on the assignment was an inadvertent error and that the official name of the company in the records of the corporation authority for the State of Israel at the time, as evidenced by the attached change of name certificate, had no space between TURBO and SEAL and used the full spelled out version of the form of company, "LIMITED PARTNERSHIP."

At least one of the inventors who signed the assignment document in 2013 is not available to sign a correction or to execute a new assignment using the correct form of the name of the assignee company. Accordingly, as Managing General Partner of assignee company, I hereby request that the assignment records of the U.S. Patent and Trademark Office be corrected to show that the name of the assignee company in the assignment from the inventors dated July 28, 2013, is TURBOSEAL LIMITED PARTNERSHIP.

I hereby further declare further that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or any patent issued thereon.
