

We further agree, without any payment by Nestec other than actual expenses incurred, to communicate to Nestec, its representatives or agents, any fact relating to said Invention or improvements thereon, including evidence for ex parte or inter partes legal proceedings, whenever requested; furnish to Nestec any data, information, exhibits, memoranda, or other evidence in our possession relating to said Invention or improvements thereon; testify in any ex parte or inter partes legal proceedings whenever requested; and execute and deliver, upon request, all lawful papers required to make any of the foregoing provisions effective.


